I love this quote so much and over the past five years I have found it to be so true of our community. The lives of the neediest children in Klamath County have been improved through our community's collective giving of their time and monies.

We have been able to continue to recruit, train, and support the most dedicated volunteers who have given so selflessly of their time. Collectively, they have contributed over 1,749 hours, which is equivalent to \$44,477 in In-Kind donations, according to the 2019

Independent Sector Report. I am so impressed with their dedication and so grateful, as our advocates are the heart and soul of our organization.

Through the generous support of our many sponsors we were able to exceed our fundraising goal for CASAblanca. All monies raised at this event go toward providing advocacy and direct services to our foster children. Save the date for our fifth annual CASAblanca gala: March 21, 2020!

#### Protect Our Children


CASA for Children of Klamath County has joined the Ford Family Foundation's Protect Our Children project as an Associate Partner. Staff are now certified facilitators to provide Darkness to Light's Stewards of Children training in our community. Stewards trains adults to recognize the signs of child sexual abuse, react responsibly when it does occur, and most importantly, prevent child sexual abuse from occurring. This 2-hour facilitator-led discussion/documentary offers 5 Steps to Protect Our Children. The curriculum includes survivor stories, guidance from experts, and practical, empowering solutions that any adult can adopt to protect the children in their care and in their community. ### Ping Pong Ball Tower

The brain-child of our advocate, James Brown, has been such a success! The visualization of volunteer hours has not only encouraged our volunteers to report, but it also showcases the fruits of their labor. Each ball equals one hour. Each of these hours is valued at \$25, according to the 2019 Independent Sector Report. At the beginning of our fiscal year, we created a goal to raise \$50,000

in In-Kind volunteer hours. We are excited to report that we not only

doubled our reported hours from last year (2017-2019), but we also raised \$44,477 In-Kind (89%) of our \$50,000

### CASA Kid Fund

Our CASA Kid Fund continues to be a huge success! Since its inception, we have been able to provide over 160 activities and opportunities to foster children, keeping them engaged, active, and involved in school and extracurricular activities. This fund has paid for 60 sports and fitness fees, sent 41

children to camp, covered 14 music lessons, and bought back to school clothes and uniforms for more than 30 kids. We were also able to cover college courses and cost of supplies, a driver's education course, and assisted with therapy and counseling costs.

Without the generosity of Sky Lakes, we would not be able to provide these extras for our kids. We work closely with our advocates, DHS caseworkers, and foster parents to make sure our kids stay strong, active, and engaged in their community.

### Backpack Project

We saw a need and tackled it head on with the help of many local sponsors and the West Family Foundation. Their generosity has enabled us to provide each child in care with a backpack filled with life's essentials. Since the inception of this project, we have given out over 150 backpacks! Each backpack contains a blanket, a self-care kit, a book or journal, a pair of socks,

mittens, a hat, a pillowcase, pajamas, the Foster Children's Bill of Rights, and the DHS Foster Children's Guide. These backpacks are given out at the time of removal or when our advocates visit for the first time.

Thank you to the members of the Linus Project, Klamath Union Key Club, Dr. Tucker and Dr. Gailis, OHSU/OIT Nursing students, SMART, Jean Handy, and many other local artisans. We are especially grateful to the West Family Foundation for continuing their support of this very special project.



### Program Statistics 2018-2019

### CASA Annual Report



**225** foster children referred to CASA for Children of Klamath County Program. This is the number of children referred into the program. Dependent on status of case, a CASA may or may not be assigned.

**131 foster children served** by CASA Advocates. This is the number of children that have had a CASA assigned to their case during our fiscal year.



51 Active CASA Advocates

17 Newly Trained CASA Advocates

**1,749 Volunteer Hours.** This is the number of hours with the child, court time, travel, prep time, and other activities involved in advocating. This is a self-report and the number may be higher.

**8,452 Volunteer Miles** traveled. These are the miles traveled by our volunteers and are not reimbursed by our program. This is a self-report and the number may be higher.

Thank you to all of our donors! With your assistance we have been able to continue our services and provide much needed advocacy to our local foster children. CASA's long-term financial goal is for sustainability and continued growth in order to serve 100% of the children referred to our program. We continue to diversify funding streams to meet these strategic goals and are excited to report that once again, we have reached our fundraising goals. Next year our goal is to continue this positive trajectory in our local fundraising with expansions at our annual CASAblanca Gala and Fall Ask. Local fundraising is vital to sustainability as we see grants come and go and fluctuations in government support.

We would also like to thank Cascade Health Alliance (CHA). We could not do what we do without their ongoing support. 

This year we hired a new grant writer, Mary Ratliff, who has continued to increase our foundations, trusts, and corporate giving.

Fifty percent of our dollars were spent for direct services to the children we serve and to our volunteer advocates through special projects, recruitment, training, and advocate support. These services include extensive background checks, interviews, 30 hours of training, court attendance for active cases, assistance on child visits, 12 annual hours of continuing education, and court report writing assistance. The remaining expenditures are allocated to fundraising (19%), program support (12%), administrative (10%), and Victims of Crime Act (VOCA) (9%). We continue to provide extra support to local foster children in the form of backpacks loaded with age-appropriate essentials, Gifts for the Child during the holidays, and activities and items through our CASA Kid Fund (please see Special Projects, pg. 6.) The goal of all our efforts remains serving 100% of the children referred to our program.
