### A SPECIAL FAREWELL

## Lloyd King is retiring after 22 years of advocacy with CASA.

Lloyd King has been with CASA for Children of Klamath County for 18 years. He came to us as a retired postal service employee, a father, and a grandfather. Lloyd is wise beyond his years regarding advocating for children, pulling from his own experiences.

He began his journey with CASA in Butte County in Chico, CA with their first CASA group in January of 2000.

During his time with us, he went through CASA pre-training in

November 2004 and later, in 2010, became a Peer Coordinator.

Lloyd oversaw several CASAs as a Peer Coordinator, had numerous cases of his own, and advocated for many children. He was also awarded the CASA for Children of Klamath County Myron Gitnes Volunteer of the Year in 2015.

Through his years with CASA, he has advocated under five Executive Directors and eight Program Coordinators. He was assigned 16 cases, advocating for 27 children. As a Peer Coordinator, he oversaw 14 CASAs, which included 13 cases and 22 children. He took on these Peer Coordinator cases while he oversaw his own CASA cases. One of Lloyd's longest lasting cases was 12 years from 2006 until his CASA child turned 18 years in 2018.

Lloyd was always willing to help recruit new CASAs and would join staff at many outreach events including Coffee with CASA, pre-training events, such as the Introduction to CASA, and during pre-training to discuss his experiences as a CASA.

During all his time with CASA, Lloyd was also the Director of the non-profit program Grandparents as Parents.

Lloyd, we wish you the very best in this next chapter. Your advocacy, witty humor, and dedication will be greatly missed. From everyone at CASA, thank you.




## LOCAL & NATIONAL CASA IMPACT

### **KLAMATH COUNTY STATISTICS**

TOTAL CASAs IN 2021: 30 **TOTAL KIDS SERVED IN 2021: 49** 

Each CASA advocated for 1-2 children last year.



**TOTAL NUMBER OF KIDS IN CARE: 146** 

In 2021, we were able to serve 34% of children that came into care in Klamath County.

to find safe, permanent housing when they've been appointed a CASA

Foster children are **MORE LIKELY** 



to succeed in school when they've been appointed a CASA

### NATIONAL STATISTICS

TOTAL NUMBER OF CASAs IN THE U.S. IN 2020: 93,225

TOTAL NUMBER OF FOSTER KIDS WITH CASAs IN THE U.S. IN 2020: 242,236

Annually, CASA is able to provide advocacy for 242,236 foster children with 93,225 advocates. On average, each CASA advocates for 2-3 children per year.
